## RE: Right of way for preventive maintenance on underground gas pipes.

Dear Sirs,

We hereby grant you the mandatory permanent right of way for the installation of the underground internal connection, in favour of , (hereinafter The Distributor)

and for performing the regulatory preventive maintenance of these installations in accordance with the current legal provisions.

Likewise, we agree not to plant any trees or long-stemmed shrubs, or raise buildings or build sewers, at a distance of less than 1.5 m from the pipe's axis, and not to perform any ploughing, digging or other similar works to a depth of more than 40 cm on a one-metre strip of land to each side of the pipeline.

This assignment of right of way will be notarised at the time that is deemed appropriate, at the The Distributor's request.
